RFQ: INSTALLATION AND UPGRADING OF ELECTRIC FENCE

Walter Sisulu Local Municipality is hereby inviting tenders from suitably qualified service providers to install and upgrade an electric fence at Buffelspruit Nature Reserve in Malestwai. The detailed specifications are set out below.

Tenders should be submitted in a sealed envelope marked "NOTICE 89/2024/2025 TENDER: INSTALLATION AND UPGRADING OF ELECTRIC FENCE" at No 1 Jan Greyling Street, BURGERSDORP 9744, not later than Friday, 09 May 2025 at 12h00, when all tenders will be opened in public at the reception. No late bids will be accepted for consideration.

INSTALLATION AND UPGRADING OF ELECTRIC FENCE AT BUFFELSPRUIT

The following conditions will apply:

- Price(s) quoted must be valid for at least ninety (90) days from the date of your offer.
- Price(s) guoted must be firm and must be inclusive of VAT.
- A firm delivery period must be indicated.
- A valid Tax Clearance certificate or SARS Pin
- Copies of Company Registration Certificates and Identity documents.
- Central Supplier Database (CSD) registration form.
- MBD 4 Forms
- Municipal accounts are not older than three months from the date of the tender or lease agreement for the company renting the property.
- No faxed or e-mailed documents will be accepted.
- All copies must be originally certified.
- Quotations which are late, incomplete, or unsigned will not be accepted.
- The tenderer or any of its directors/ shareholders is not listed on the register of tender defaulters.
- The municipality does not bind itself to accept the lowest or any tender and reserves the right to accept the whole or part of the bid.

NB: No quotations will be considered from persons in the service of the state. Failure to comply with the above conditions will invalidate your offer.

1. SCOPE OF WORK

- 1.1 Buffelspruit Nature Reserve needs a strong, high-voltage electric fence which will be adequate for keeping the buffaloes within the nature reserve premises and preventing them from breaking through.
- 1.2 The electric fence must encircle the entire nature reserve and comprise at least 2 (two) electrified lines with spacers and insulators separating them from the main fencing net.
- 1.3 The border of the Buffelspruit Nature Reserve is 17km in length, which should be electrified. However, the service provider will be requested to inspect and fix the existing electric fence and expand where applicable. A supplementary list to RFQ can be made if the inspection reveals items omitted from the list. The proposal must be submitted in a separate sheet clearly marked, "Additional Work".
- 1.4 The power source for electricity in the nature reserve is at the nature reserve office located at the main entrance point of the nature reserve, along the R58 road.
- 1.5 A control unit with switches for the electric fence must be part of the electrification set.
- 1.6 A twenty-hour (24-hour) backup supply (UPS) connected to a solar panel is also required for a constant and undisturbed electric supply to the electric fence.
- 1.7 The energiser must have a Certificate of Compliance.
- 1.8 As a general rule, the live wire should be at nose or chest height to the buffalo we wish to control.
- 1.9 Install fence monitors and react promptly if there is a problem.
- 1.10 Make sure all joints are securely clamped and use line clamps where necessary.
- 1.11 A control unit with switches for the electric fence must be part of the electrification set.
