NOTICE ON MUNICIPAL ACCOUNT DISPUTE FOR THE 2025/26 FINANCIAL YEAR

Customers can lodge a complaint, make a request or dispute on service fees and rates on their municipal account.

This is in line with Section 95(f) of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000), which provides as follows:

Customer care and management

95. *In relation to the levying of rates and other taxes by a municipality and the charging of fees for municipal services, a municipality must, within its financial and administrative capacity–*

(f) *provide accessible mechanisms for those persons to query or verify accounts and metered consumption, and appeal procedures which allow such persons to receive prompt redress for inaccurate accounts.*

A dispute can be lodged after the general complaint's procedure was followed and you are not in agreement with the outcome.
